## **General Environmental Duty**





# From 1 July 2021 the Environment Protection Act 2017 (Vic) will provide a prevention- focused regulatory scheme and at its heart is the general environmental duty.<sup>1</sup>

The general environmental duty is actionable by eligible persons via civil remedies and by the Environment Protection Authority as a civil penalty and indictable criminal offence.

It is not clear if the general environmental duty is an absolute liability offence observing the availability of civil remedies and civil penalties and Parliament's intention to limit an accused presumption of innocence by raising its due diligence in defence.<sup>2</sup>

#### **Civil Remedy**

Civil remedies including restraining conduct, requiring a specific act, provision of financial assurance, payment of compensation and other ancillary matters are available to an <u>eligible person</u> whose interests are affected and has leave of the Court.<sup>3</sup>

#### Criminal Offence (criminal penalty or civil penalty)

Contravention of the <u>general environmental duty</u> in the course of <u>conducting</u> a business or an undertaking is an indictable<sup>4</sup> criminal offence.<sup>5</sup>

A person 'conducts' a business or undertaking:6

- a. whether or not the business or undertaking is conducted for profit or gain; and
- b. whether or not the business or undertaking is conducted by a government or public authority.

A person does **not conduct** a business or undertaking merely because the person is engaged in an activity that:<sup>7</sup>

- a. is primarily domestic or private and not conducted for profit or financial gain; or
- b. solely in the person's capacity as an employee or officer of another person or on a voluntary basis.

The maximum criminal penalty<sup>8</sup> and the maximum civil penalty<sup>9</sup> for contravention of the general environmental duty are 10,000 and 2,000 penalty units for a body corporate and natural person, respectively.

The maximum penalty<sup>10</sup> doubles (and for a natural person includes 5 years imprisonment for aggravated offending, which in an indictable offence)<sup>11</sup> where:

- a. a person intentionally or recklessly contravenes the <u>general</u> <u>environmental duty;</u> and
- b. the contravention results in <u>material harm</u> to <u>human health</u> or the <u>environment</u> from <u>pollution</u> or <u>waste</u>; and
- c. the person knew or reasonably should have known that the contravention would result in <u>material harm</u> or would be likely to result in <u>material harm</u> to <u>human health</u> or the <u>environment</u> from <u>pollution</u> or waste.

**'Material harm**'<sup>12</sup> in relation to <u>human health</u> or the <u>environment</u> means <u>harm</u> that is caused by <u>pollution</u> or <u>waste</u> that:

- a. involves an actual adverse effect on <u>human health</u> or the <u>environment</u> that is not negligible; or
- b. involves an actual adverse effect on an area of high conservation value or of special significance; or
- c. results in, or is likely to result in, costs in excess of the threshold amount (at present, \$10,000)<sup>13</sup> being incurred in order to take appropriate action to prevent or <u>minimise</u> the <u>harm</u> or to rehabilitate or restore the <u>environment</u> to the state it was in before the <u>harm</u>.

<u>Harm</u> may become <u>material harm</u> regardless of the period of time in which the <u>harm</u> occurs and as a result of:

- a. a single occurrence of harm arising from an activity; or
- b. multiple occurrences of harm arising from the same activity; or
- c. the cumulative effect of <u>harm</u> arising from an <u>activity</u> combined with <u>harm</u> arising from other <u>activities</u> or factors.

Contravention of the general environmental duty is not an infringement notice offence.<sup>14</sup>

# **General Environmental Duty**

"A person who is engaging in an **activity** that may give rise to risks of harm to human health or the **environment** from pollution or waste must minimise those risks, so far as reasonably practicable."

#### "ACTIVITY" inclusive definition [s3(1)]

- · storage or possession of waste
- prescribed activity for permission [r16 and Sch 1]
- development activity [r16(1) and Sch 1 column 3 & 4]
- operating activity [r16(2) and Sch 1 column 3 & 4]
- permit activity [s16(3) and Sch 1 column 3 & 4]
- registration activity [s16(4) and Sch 1 column 3 & 4]

#### "HARM" exhaustive definition [s4]

means adverse effect on human health or the environment, of whatever degree or duration, and includes

- adverse effect on amenity of a place or premises that unreasonably interferes with or is likely to unreasonably interfere with enjoyment of the place or premises [s4(1) (a)]
- a change to the condition of the environment so as to make it offensive to the senses of human beings [s4(1) (b)]
- anything prescribed (nothing prescribed)

Harm may arise as a result of cumulative effect. [s4(2)]

#### "HUMAN HEALTH" inclusive definition [s3(1)]

· Psychological health

#### "ENVIRONMENT" exhaustive definition [s3(1)] means:

- physical factors of surroundings of human beings
- land, waters, atmosphere, climate, sound, odour and taete
- biological factor of animals and plants:
- · social factor of aesthetics.

#### "land" inclusive definition [s3(1)]

means any land, public or private:

- any buildings or structures permanently affixed to the land; and
- groundwater

#### "groundwater" exhaustive definition [s3(1)]

means any water contained in or occurring in a geological structure / formation or artificial landfill below the land surface.

#### "waters" inclusive definition [s3(1) and (3)]

means.

- reservoir, tank or billabong; [s3(1)(a)]
- anabranch, canal, spring, swamp; [s3(1)(b)]
- natural /artificial channel, lake, lagoon, waterway or dam; [s3(1)(c)]
- tidal water, coastal water or groundwater; [s3(1)(d)]
- bed / subsoil beneath waters; [s3(3)(a)]
- airspace superjacent to waters; [s3(3)(b)]
- open, piped or underground drain excluding that which conveys waste as part of treatment of waste. [s3(3)(c)]
- the River Murray and waste/pollution from Victorian bank. [s8(3)]

#### "WASTE" inclusive definition [s3(1)]

- matter (solid, liquid, gas, radioactive) deposited, discharged, emitted or disposed into the environment in manner that alters environment:
- greenhouse gas;
- matter discarded, rejected, abandoned, unwanted or surplus (may have potential use or value);
- matter for resource recovery;
- anything prescribed (nothing prescribed to date). [RPW&IW]

#### "deposit" exhaustive definition [s3(1)]

means the act of parting with possession of waste or litter and includes burning waste or litter.

#### "greenhouse gas substance" exhaustive definition [s3(1)]

means

- carbon dioxide, methane, nitrous oxide or Sulphur hexafluoride (gas or liquid);
- hydrofluorocarbon and a perfluorocarbon (gas or liquid) specified in regulations made by National Greenhouse and Energy Reporting Act 2007 (Cth)

#### "resource recovery" exhaustive definition [s3(1)]

means:

- preparation for reuse of waste;
- · recycling waste;
- · reprocessing waste;
- · recovering energy or resources from waste;
- anything prescribed (nothing prescribed to date).

#### "reuse" exhaustive definition [s3(1)]

means use of waste for a purpose for which is was used before it became waste.

#### "industrial waste" exhaustive definition [s3(1)]

#### means:

- waste arising from commercial, industrial or trade activities or laboratories:
- anything prescribed.

#### Prescribed: [r60]

- waste from any source received at a place/premises which stores/handles waste generated at another site for resource recovery or off-site transfer or disposal;
- waste transported for fee or reward, other than the collection of kerbside waste by or on behalf of a council or waste and resource recovery group.

#### "POLLUTION" [s3(1) inclusive definition]

any emission, discharge, deposit, disturbance or escape of:

- Solid, liquid or gas, or combination of, including smoke, dust, fumes or odour:
- noise:
- heat:
- anything prescribed (nothing prescribed)

#### "MINIMISE" exhaustive definition [s6(1)]

- eliminate [s6(1)(a)]
- reduce (if cannot eliminate) [s6(1)(b)]

risk of harm to human health or the environment so far as reasonably practicable.

#### "REASONABLY PRACTICAL" considerations [s6(2)]

to determine must consider:

- likelihood of risks eventuating; [s6(2)(a)]
- degree of harm that would eventuate; [s6(2)(b)]
- knowledge of harm, risk and way to eliminate/reduce; [s6(2)(c)]
- · availability and suitability of ways to eliminate/reduce; [s6(2)(d)]
- cost to eliminate/reduce. [s6(2)(e)]

#### **Required standard**

#### Any business or undertaking

A person conducting a business or undertaking contravenes the general environmental duty if the person fails, so far as reasonably practicable, to:<sup>15</sup>

- a. use and maintain plant, equipment, processes and systems in a manner that minimises risks of harm to human health and the environment from pollution and waste;
- b. use and maintain systems for identification, assessment and control of risks of harm to human health and the environment from pollution and waste that may arise in connection with the activity, and for the evaluation of the effectiveness of controls;
- c. use and maintain adequate systems to ensure that if a risk of harm to human health or the environment from pollution or waste were to eventuate, its harmful effects would be minimised;
- d. ensure that all substances are handled, stored, used or transported in a manner that minimises risks of harm to human health and the environment from pollution and waste; or
- e. provide information, instruction, supervision and training to any person engaging in the activity to enable those persons to comply with the general environmental duty.

Design, manufacture, installation or supply of a substance, plant, equipment or structure

A person conducting a business or undertaking and engaging in an activity that involves the design, manufacture, installation or supply of a substance, plant, equipment or structure, contravenes the general environmental duty if the person fails, so far as reasonably practicable, to:<sup>16</sup>

- a. minimise risk of harm to human health and the environment from pollution and waste arising from the design, manufacture, installation or supply of the substance, plant, equipment or structure when the substance, plant, equipment or structure is used for a purpose for which it was designed, manufactured, installed or supplied; or
- b. provide information regarding the purpose of the substance, plant, equipment or structure and any conditions necessary to ensure it can be used in a manner that complies with the general environmental duty.

The Victorian Government confirmed that the Environment Protection Authority will provide education, support and guidance addressing compliance with the general environmental duty, and that Compliance Codes, prepared in partnership with industry, will identify the best ways to comply.<sup>17</sup>

As at the date of this publication no Compliance Codes<sup>18</sup> have been released.

The Environment Reference Standard 2021 is not a compliance standard or code and does not prescribe matters for the purpose of the general environmental duty.<sup>19</sup>
