Russell Kennedy – Governing Body Responsibilities Toolkit



From 1 December 2023, approved providers of aged care will be required to change their Governing Body structure and implement new processes. There have been a number of reforms to governance introduced following the Aged Care Royal Commission's criticisms of the boards of aged care providers. The new Aged Care Act will undoubtedly continue this theme and ratchet up the requirements of Governing Bodies.

It is imperative that Directors of Boards, members of Committees of Management or other Governing Bodies not only understand these reforms, they must demonstrate through their leadership the expected standards of behaviour and have a practical understanding of how approved providers are implementing the changes.

1. Governing Body Responsibilities Training

2. Governing Body Responsibilities Manual

4. Quality Care Advisory Body Terms of Reference

The Quality Care Advisory Body will be an integral part of the governance structure with a process that significantly changes the Governing Body's obligations in relation to quality and safety. Our Terms of Reference provide the Advisory Body and the Governing Body a clear process for managing the relationship and complying with the legislation. The Terms of Reference reflect the legislative obligations and the Commission's guidance on meeting those obligations.

The Terms of Reference set out the overriding purpose of the advisory body, the functions of the body and the membership requirements. The documents also set out the frequency of meetings, the requirements for quorum to be met and how resolutions are passed, provide for review of the body's activities and, where relevant, the obligations of members of the bodies. They also set out record keeping requirements in relation to each body.

5. Consumer Advisory Body Terms of Reference

Approved providers need to offer their consumers and representatives the opportunity to set up a Consumer Advisory Body at least once a year. The Consumer Advisory Body will be an important mechanism for engaging with your consumers and improving your feedback, complaints and improvements processes. Approved providers will need to be proactive in making the offer, setting up the Consumer Advisory Body and helping to run it

The Terms of Reference set out the overriding purpose of the advisory body, the functions of the body and the membership requirements. The documents also set out the frequency of meetings, the requirements for quorum to be met and how resolutions are passed, provide for review of the body's activities and, where relevant, the obligations of members of the bodies. They also set out record keeping requirements in relation to each body.

6. Decision-making Framework to assess Independent Non-Executive or Clinical Care Director

This decision-making framework assists you to collect relevant information and to then determine whether a person qualifies as an Independent Non-Executive Director or Clinical Care Director by reference to relevant criteria, to assess the information for materiality and to record your decision and reasons.

7. Checklist for Application for Exemption from Governing Body Composition Requirements

This checklist assists you to collect and record relevant information to complete the application for an exemption from the Governing Body composition requirements.

8. Checklist for Governing Body Decision-Making

This checklist assists you to identify key aspects of decision-making framework with respect to the Governing Body and the shareholders or members.

Governing Body / Key Personnel Responsibilities Manual

As a member of the Governing Body and as a member of the Key Personnel category of Governing Person, members must demonstrate they have a practical understanding of the particular responsibilities and requirements relating to organisational governance and Key Personnel requirements.

This Manual describes the responsibility of the approved providers to ensure they are reasonably satisfied that individuals are suitable to be involved in the provision of aged care as Key Personnel and those that apply to individuals. It provides a roadmap to the particular responsibilities and requirements that Key Personnel who are members of the Governing Body must have an understanding of to satisfactorily discharge their obligations.

This Manual complements the Governing Body Responsibilities Reforms Manual by providing a broader organisational context than the reforms that are focused on in the Reforms Manual.

10. Reframing your Constitution

The governance reforms provide an opportunity for approved providers to review their constitutions and modernise them to reflect the expectations of stakeholders. We can assist approved providers with this process including recommendations for change.

11. Governance Reforms Advice

We can provide written advice about:whether any proposed or current directors meet the independent non-executive or clinical care experience requirements; any exemptions that could apply for the governing body membership requirements; and any necessary or desirable amendments to the constitution to meet or respond to the requirements of the reforms.

12. Exemption Application
