The presentation provided an overview of:

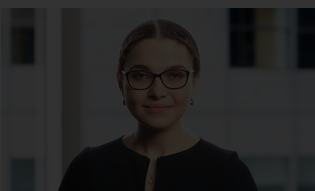
- child support obligations and the calculation of child support;

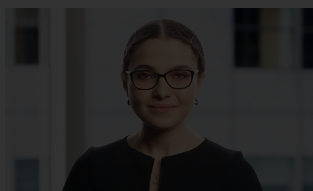
